# Street Sweeping Rates

A. Lewis explained that the current rate for SRCOG street sweeping services is \$85/hour, which is significantly less than other professional organizations. The last time rates were raised was 2017 and A. Lewis recommended raising the rate to \$90/hour. Members discussed and decided to raise to \$95/hour due to the increase in prices of fuel, maintenance, and labor.

A motion was made by E. Skiba and seconded by D. Thomas to raise the SRCOG street sweeping services to \$95/hour beginning with the 2022 season. All in favor. Motion carried.

## <u>Train Station Appraisal – 500 Amity Street</u>

SRCOG received an appraisal for the Train Station at 500 Amity Street from Howard Hanna Appraisal Services. After discussing with F. Muscante, A. Lewis recommends receiving a second appraisal from another company that the solicitor is familiar with. Members discussed rental amounts, building costs and the possibility of selling the property in the future.

A motion was made by E. Skiba and seconded by D. Schulte to allow A. Lewis and staff to acquire a second appraisal of the Train Station located at 500 Amity Street in Homestead. All in favor. Motion carried.
