LISTENING SESSION NOTES

The Jefferson Regional Foundation has been enlisted by the Allegheny County Health Department to distribute, in the form of grants, settlement funds received from U.S. Steel resulting from the 2018 fire that negatively affected the Mon Valley. In advance of opening their grant application portal, JRF held three listening sessions throughout October 2024 with the goal of understanding resident's needs and clarifying the grant application process. Almost 80 residents and community partners shared their personal stories, health challenges, and effective ways to meet community need and increase health and well-being with the Mon Valley Clean Air Funds. "We are incredibly grateful to the residents and community stakeholders who attended one or all the sessions," says Communications Coordinator Isaiah Warfield in an email to local organizations. "Their willingness to share critical information is an intangible asset that is both honored and respected."

The Jefferson Regional grantmaking team has compiled a summary report highlighting the ideas of residents, recommendations for project ideas, and next steps for non-profit organizations wishing to apply for grant funds. The Jefferson Regional Foundation will consider the themes in this report when evaluating Mon Valley Clean Air Fund grant proposals.

The first round of grant applications will be due in mid-January.
